



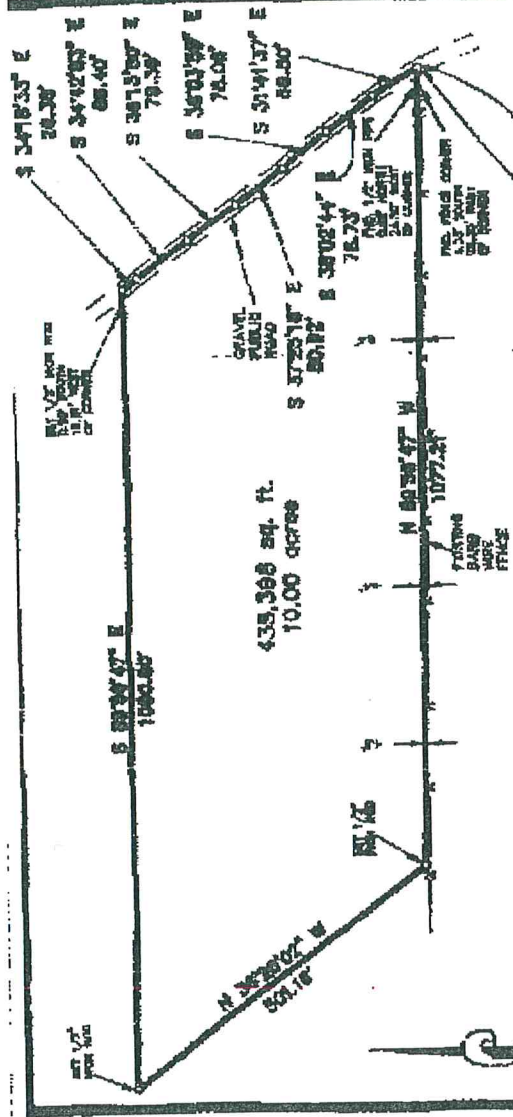

Starts of Mississippi, County of Copiah, Township 9 North, Range 5 East, Section 13, a part of the SW 1/4 of the SE 1/4 and in a part of the SE 1/4 of the SW 1/4

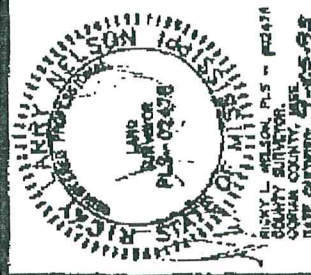
**DESCRIPTION OF LANDS:**

A parcel of land containing 11.000 acres, more or less, situated in a part of the Southwest One-Quarter (SW 1/4) of the Southeast One-Quarter (SE 1/4) and in a part of the Southeast One Quarter (SE 1/4) of the Southwest One-Quarter (SW 1/4) of Section 13, Township 9 North, Range 5 East, Copiah County, Mississippi, being more particularly described by metes and bounds as follows:

Commence at the intersection of the centerline of a gravel Public road and the South line of Section 13, Township 9 North, Range 5 East, Copiah County, Mississippi, said point being the Point of Beginning of the following described parcel of land:

From the Point of Beginning run thence North 89 degrees 56 minutes 47 seconds West along the South line of Section 13 for a distance of 1077.21 feet to a One-Half Inch (1/2) Iron rod; run thence North 36 degrees 20 minutes 02 seconds West leaving the South line of Section 13 for a distance of 501.16 feet to a One-Half Inch (1/2) Iron rod; run thence South 89 degrees 56 minutes 47 seconds East for a distance of 1080.80 feet to a point on the centerline of the above referenced gravel roadway; run thence along the centerline of said roadway as follows: South 34 degrees 18 minutes 33 seconds East for a distance of 26.38 feet; run thence South 34 degrees 42 minutes 53 seconds East for a distance of 80.40 feet; run thence South 38 degrees 13 minutes 00 seconds East for a distance of 79.39 feet; run thence South 37 degrees 25 minutes 18 seconds East for a distance of 80.82 feet; run thence South 36 degrees 03 minutes 59 seconds East for a distance of 78.06 feet; run thence South 58 degrees 07 minutes 44 seconds East for a distance of 78.73 feet; run thence South 31 degrees 41 minutes 37 seconds East for a distance of 68.30 feet to the Point of Beginning.
